STRIDE AHEAD CORONA VIRUS WAIVER

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19 In Favor of Stride Ahead, Inc.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Stride Ahead, Inc. has put in place preventative measures to reduce the spread of COVID-19; however, Stride Ahead, Inc. cannot guarantee that anyone participating in a Stride Ahead program will not become infected with COVID-19. Further, such participation could increase the risk of the participant and others contracting COVID-19.

By signing this agreement as the participant, parent or guardian, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I, my child(ren) or others for whom I am guardian may be exposed to or infected by COVID-19 by participating in a Stride Ahead program (including but not limited to attending lessons or volunteering) and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 by participating in a Stride Ahead program may result from the actions, omissions, or negligence of myself and others, including but not limited to Stride Ahead, Inc. or its employees, contract workers, volunteers, or program participants.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself, my child(ren) or others for whom I am guardian (including but not limited to personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind) that I, my child(ren) or others for whom I am guardian may experience or incur in connection with participation in a Stride Ahead, Inc. program (“Claims”).

On my behalf and on behalf of my child(ren) and others for whom I am guardian, I hereby release, covenant not to sue, discharge, and hold harmless Stride Ahead, Inc., its employees, contract workers, volunteers, program participants, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release and the other covenants and agreements herein relate to any Claims based on the actions, omissions, or negligence of Stride Ahead, Inc., its employees, contract workers, volunteers, program participants, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Stride Ahead, Inc. program.
